Fortis has trenched an electrical line to our community from the main powerline that runs along Lochend Road. The permit has been obtained and our electrician will begin work in early 2025 to better illuminate the front entrance sign.






Pond Reclamation Project is COMPLETE

It's been a project that's been ongoing for quite some time; the history of the pond was shared at the 2024 AGM. After the liner was removed, the electrical lines for the pump (the pond's water fountain) were disconnected from power, and the land was prepared by Yundt Solutions. The land was worked to ensure it was even and ready to receive hydroseeding. Top Spray was awarded the hydroseed work and they managed complete the application prior to winter arriving. When the snow melts and our spring rains begin, we will see our efforts realized when grass grows in the previous pond area. This area will not be mowed and maintained, but will be allowed to return to a somewhat natural and wild state. We anticipate some wetter areas within that space and hopefully birds and other wildlife will thrive there.

Rural living isn't some lawless land, we have to abide by bylaws laid out by the county as well as the ones established in our residential community. Here are two spotlights:

BCE HOA:

39. f.

no activity shall be permitted on any lot which causes offensive noise, dust, smell, smoke traffic generation or other nuisance.

Rocky View County bylaw C-5758-2003:

Nuisance 4 a: The owner of an animal shall ensure that such animal shall not

(ii) bite, bark at excessively, or chase livestock, bicycles, automobiles, or other vehicles

(iii) excessively and unreasonably bark, howl or otherwise disturb any neighbour(s) or person
